### MARCH MEANS INVENTORY TIME

#### ADC INVENTORY INFORMATION

ADC's offices & warehouses will be closed for inventory on Wednesday April 1. Normal Operation will resume on Thursday April 2 with the exception of warehouse receiving - See Below.

#### WAREHOUSE RECEIVING

There will be no incoming product received at the warehouses on Friday March 27, Monday March 30, Tuesday March 31 and Wednesday April 1 - except Specials - See Below

#### SPECIALS

Specials will be received as normal on Thursday March 26, Friday March 27, Monday March 30 and Tuesday March 31. Specials will not be received on Wednesday April 1.

#### ORDER CUT-OFF

All orders expected to be delivered/picked-up on Wednesday April 1 must be placed by 2:00pm on Tuesday March 31. All orders placed after 2:00pm on Tuesday March 31 will **NOT** be delivered/picked-up until your next scheduled delivery/pick-up day.

#### DEALER PICKUPS

- Tuesday March 31 - All regularly scheduled dealer pick-ups will proceed as usual.
- Wednesday April 1 - All regularly scheduled dealer pick-ups will need to be scheduled with the Operations Dept. prior to Friday March 27. All merchandise will need to be picked up by 7:30am on Wednesday April 1.
- Thursday April 2 - All dealer pick-ups will proceed as usual.

#### DEALER DELIVERIES VIA ADC TRUCKING

- Tuesday March 31 - All regularly scheduled dealer deliveries will proceed as usual.
- Wednesday April 1 - All regularly scheduled dealer deliveries will proceed as usual.
- Thursday April 2 - All regularly scheduled dealer deliveries will proceed as usual.

#### DEALER DELIVERIES VIA THIRD PARTY TRUCKING

##### STELLA, D&J, QUICK DELIVERY, J&J, AM HOME DELIVERY

- Tuesday March 31 - All regularly scheduled third party deliveries will proceed as usual.
- Wednesday April 1 - All merchandise being delivered by a third party trucking co. must be picked up by 7:30am.
- Thursday April 2 - All regularly scheduled third party deliveries will proceed as usual.

#### DIRECT and SPECIAL ORDERS

Direct and Special Orders placed on Wednesday April 1 will be processed and received as normal.

#### WAREHOUSE TRANSFERS

Merchandise transferred between warehouses on Tuesday March 31 will be manifested deliveries for Thursday April 2 only. Merchandise for backorders will **NOT** be transferred on Tuesday March 31.

#### SHOW ORDERS

Show Orders will **not** be processed for delivery or pick up on Wednesday April 1. Normal Show Order processing will resume on Thursday April 2
