**Serial Fragment Search** - the program will no longer appear preloaded with a model number.

**Emails** – the ability to view an ADC internal email as a PDF document, which can be printed and saved locally.

### **Vendor Credit Inquiry – NEW**

Allows you to look up information regarding your Credit Request from Vendor

### **Research Inquiry – NEW**

Allows you to look up information regarding of your Request for Research Information
