in observance of Christmas

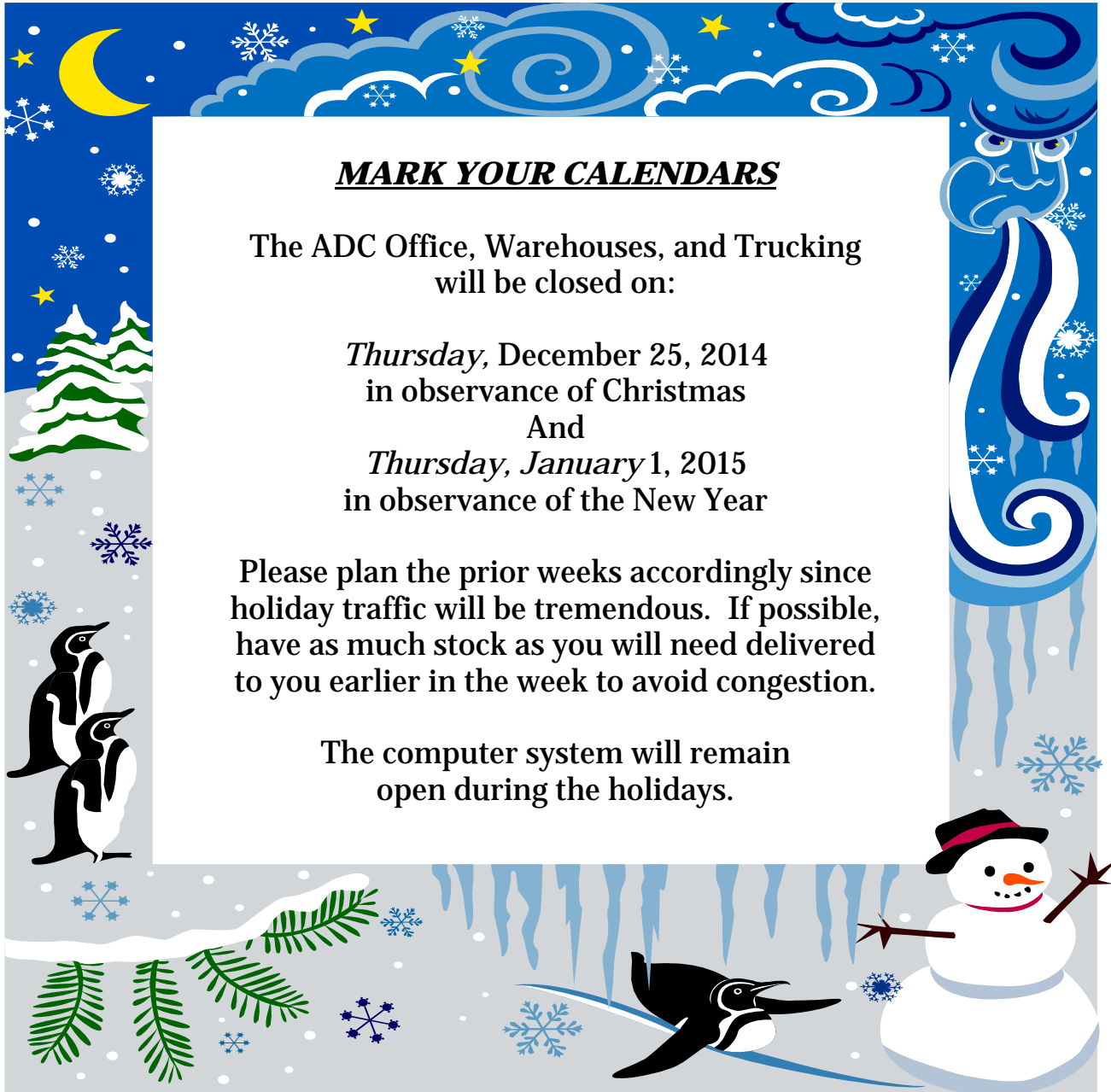
